

## 2024 REACH declaration (Regulation (EC) No. 1907/2006)

Dear valued customer,

Hereby we confirm that the following end products:

- **Zinc metal (SDS 48875)**
- **Zinc alloys for hot dip galvanizing / ZnAl alloys (SDS 49013)**

which are marketed, offered and distributed by Nyrstar Sales & Marketing AG, do not contain any of the substances mentioned in the Candidate list of Substances of very high concern (SVHC) for Authorisation published by ECHA, at a concentration above 0.1 % w/w. We also confirm that the above-mentioned Nyrstar's end products contain neither any of the substances mentioned in the Authorisation list (Annex XIV), nor substances restricted under REACH (Annex XVII), at a concentration above 0.1 % w/w.

The following end products contain magnesium which is included in the Restriction list (Annex XVII), but the identified uses of the alloy are not covered by the restrictions included in Annex XVII:

- **Zinc alloys die casting / ZnAlCuMg (SDS 49012)**
- **ZAM / ZnAlMg (SDS 58461)**

The following end product contains nickel for which certain uses are restricted under Annex XVII of REACH Regulation (EC) No 1907/2006:

- **Zinc alloys for hot dip galvanizing / ZnNiBi alloys (SDS 49014)**

The end product **sulfuric acid (SDS 51613)** is subject to restrictions of Annex XVII of Regulation (EC) No. 1907/2006.

The following end products contain substances included in the Candidate list of Substances of very high concern for Authorization and in the Restriction list at a concentration above 0.1 % w/w:

- **Zinc alloys for continuous galvanizing / ZnPb alloys (SDS 49015)**
- **Cadmium metal (SDS 51612)**
