Skin Non irritant. Metallic lead is very poorly absorbed through the skin and is therefore not considered a hazard

through this route of exposure.

Eye Exposure considered unlikely. Due to product form and nature of use, the potential for exposure is reduced.

Sensitisation Not classified as causing skin or respiratory sensitisation.

Mutagenicity The evidence for genotoxic effects of lead is contradictory, with numerous studies reporting both positive and

negative effects. Responses appear to be induced by indirect mechanisms, mostly at very high

concentrations that lack physiological relevance. Lead is suspected of causing genetic defects.

Carcinogenicity Lead compounds (inorganic) are classified as probably carcinogenic to humans (IARC Group 2A). Arsenic

and inorganic arsenic compounds are classified as carcinogenic to humans (IARC Group 1).
